AGREEMENT AND RELEASE

By signing this document, the Applicant agrees to all applicable terms, conditions, stipulations, releases, and waivers contained in this document. All Foundation Outreach International Projects ("Projects" or "Project"), including any Project to which this application pertains, are operated by Foundation Outreach International, a Texas Nonprofit Corporation, and all Projects maintain high standards of dress and conduct based on the Holy Bible. The Applicant agrees to carefully read and understand this document as well as any associated documents or attachments concerning the Project to which this application pertains. The rules of the Project include, but are not limited to, the following: no possession or use of tobacco or illegal drugs, no abuse of alcohol, and no sexual misconduct, theft, smoking, profanity, destruction of property, disorderly conduct or failure to cooperate fully with Project staff. Appropriate dress is required, and standards of appropriate dress include, but are not limited to, the following: no halter tops, no spaghetti straps and no other inappropriate attire. Regarding appropriate attire, Applicants should refer to the traditional standards and norms of the Church of God. Applicant agrees that the discretion of the Project staff shall control and be authoritative regarding any and all questions or disputes over appropriate dress.

Applicants who do not comply with the Project's rules and Applicants whose conduct or attitude is not consistent with the objectives of the Project, including (without limitation) the promotion of a positive environment, are subject to dismissal at the expense of the Applicant. The Applicant understands and agrees to the following: All determinations and judgments pertaining to the Applicant's continued permission to be present at the Project are within the complete discretion of the Project staff and Foundation Outreach International. Applicants who have made false statements in connection with the Project application process, or who have given incomplete information on this application and/or any collateral forms, are subject to dismissal from the Project.

As used in this document, the term "Applicant" refers to the individual making application to participate in a Project. The term "Applicant" is prospective and broad in nature, and upon acceptance of Applicant to a position at any Project, the terms, conditions, stipulations, releases and waivers set forth in this document shall apply to Applicant in his or her capacity as a Project volunteer. In the event that the Applicant is accepted to participate in a Project, Applicant agrees that all terms, consents, agreements, releases, consequences and/or waivers that resulted from the application process to which this document pertains shall survive the application process and shall continue to apply to the Applicant in his or her capacity as a Project volunteer.

General Release: The Applicant acknowledges that many Project activities are physically exerting and rigorous in nature, and as such, the risk of personal injury is a significant feature of participation in a Project. The Applicant further acknowledges that travel to foreign countries is inherently risky. Thus, Applicant participates in the Project at his or her own risk. Upon signing this document, it is agreed that the Applicant's involvement in Project activities shall be at the Applicant's own risk. Having acknowledged this, the Applicant knowingly, freely and voluntarily assumes the risk of personal injury arising from participation in Project activities. In consideration of being allowed to participate in a Project, the Applicant hereby covenants and agrees to not sue Foundation Outreach International, its officers, board of directors, employees, volunteers, helpers, contractors and/or all related entities (including Church of God, a Worldwide Association, Inc., a Florida Not-for-Profit Corporation), and the Applicant hereby releases, indemnifies and agrees to hold harmless Foundation Outreach International's negligence) which might come about from injuries, real or implied, sustained by the Applicant due to (or during the course of) the Applicant's participation in a Project.

The Applicant agrees to not hold Foundation Outreach International responsible for any such personal injuries. Exception: This provision shall not be construed to bar the Applicant from seeking the benefit of any appropriate insurance benefits or claims that may be available under Foundation Outreach International's insurance policies. However, it is strongly recommended that the Applicant have his or her own medical insurance protection. Severability clause: If any provision(s) of this document is (are) held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a court finds that any provision(s) of this document is (are) invalid or unenforceable, but that by limiting or reforming such provision(s), the remaining provisions(s) of the document would become valid or enforceable, then such provision(s) shall be limited and reformed in such a way that the remainder of the provision(s) will survive and remain enforceable.

Consent and Release Regarding Background Investigation and Character Evaluation: The Applicant understands that Foundation Outreach International will investigate the background of all applicants prior to acceptance to a Project, and the Applicant agrees to allow any investigations to proceed. The Applicant hereby gives consent to any such background investigations of any variety. The applicant hereby consents to Foundation Outreach International searching for any information that pertains to any records of arrests, convictions or any criminal file(s) maintained on Applicant, Applicant hereby releases Foundation Outreach International and any of its employees, contractors or associates from any and all liability resulting from such investigations or disclosures that are the result of such background investigations. Applicant's consent extends, without limitation, to a search of the Applicant's background, criminal history, driving record and credit history. The Applicant consents to disclosure of any such background investigation results to any Foundation Outreach International volunteer, employee, contractor, officer, director or associate. The Applicant agrees to not sue Foundation Outreach International for any claim that might arise from the disclosure of any information derived from any of the described investigations into the Applicant's background. Further, the Applicant consents to Foundation Outreach International contacting the Applicant's minister or pastor and requesting that the Applicant's minister or pastor evaluate the Applicant in terms of the Applicant's character and background. The Applicant consents to said minister or pastor freely giving his evaluation or opinion regarding the Applicant's character and background, and the Applicant agrees to not sue Foundation Outreach International or said minister or pastor for anything related to said ministerial or pastoral evaluation of Applicant's character or background. The Applicant agrees to hold harmless and refrain from suing the following individuals or entities in connection with any investigations whatsoever into Applicant's background or criminal history: Foundation Outreach International, the Applicant's minister or pastor, and any contractor, associate or volunteer of Foundation Outreach International.
